**SUBJECT:- Mandatory Public Disclosure at Home Page in school's website – reg.**

Sir / Madam,

This is in reference to the Board Circular No. CBSE/AFF/2021: 06/2021 dated 21/05/2021 whereby all the schools were advised to display of "Mandatory Public Disclosure" at Home Page in school's website under prominent icon levelled as "**Mandatory Public Disclosure**" for easy access by the member of public to ensure transparency. For this purpose, one month stipulated time period was given to the schools to display the Mandatory information in their respective school. It is again re-iterated that the information has to be displayed on the schools website as per Clause 2.4.9 of Affiliation Bye Laws 2018, as per the format prescribed in Appendix IX of Circular dated 05/03/2021 (Reference Circular No. 03/2021 dated 05/03/2021). The format of Mandatory Public Disclosure alongwith the relevant circular is once again attached herewith for ready reference.
